WCRA Minutes from the November 5, 2004 Meeting:

President Mike, AB9AX, called the meeting to order at 19:36. **Tom, N9WBW**, made a motion that the minutes of the last meeting be accepted. **Carol, KB9FYL**, seconded the motion, and it passed. In President's Announcements, Mike thanked **Bill, K9WH**, and all of the WCRA members who had participated in Three Fires Council Camporall. Mike reported the club truck was at the event, and about 100 scouts got on the radio. Mike announced that he is resigning as WCRA president because he is relocating. Vice President

Steve, N9OA, thanked Pat, K9JAU, for bringing refreshments for the meeting. He said the Annual Club Auction is the November program and Peter, N9HDW, will present a video of Walter Cronkite talking about ham radio. He said there will be no meeting in December. The January program will be devoted to Hamfest. After that, programs are open and Steve asked members for their suggestions. Secretary Mary, K9GAL, presented a new membership application for **Bill**, **KA9LFU**. Tom made a motion to accept the applicant, Steve seconded it, a vote was taken and the membership was approved. Treasurer Jack, KA9HEL, reported on the budget. Hamfest Bruce, K9OZ, informed members there will be a Hamfest committee meeting Friday, Nov. 13 at his house in Lisle. Other desirable traits are as follows:

1. Be as approachable as possible, you never know where the next great idea is going to come from.

2. Optimism is a must. It is often easy to find a reason why an idea won't work, and many will offer such reasons. So, in order to get anything to change, the individual must have the courage and ingenuity to find ways to make things work. This trait is very important, if things are to change for the better.

3. Be an active, on-the-air ham radio operator. This helps the candidate not forget what the club, and more importantly, the hobby is all about. (Read the purposes of the club in WCRA's Articles of Incorporation from time to time as well, to remember what we legally claim to be all about).

4. Checks in to Sunday night and other nets, with traffic of interest. Its always a positive thing to recognize member achievements, and member participation in a variety of events, even if only one member participates.

5. Involves the membership openly about club issues.

6. Patience - Patience is more than a virtue, it may help a candidate from ripping hair from the cranial region when things don't seem to be going the desired direction.

7. Hamfest experience. An ideal candidate will have had experience as part of the hamfest committee. This goes back to understanding the club's primary source of income.

Look on page 97, second column from the left, a third of the way down and 11A shows "Wheaton Community Radio Amateurs, W9CCU (+N9HDW), number of QSOs (2162) a power output of less than 150 watts (2), number of participants (66) and TOTAL SCORE OF 7802 POINTS! 

Special permission has been granted for a legal amateur radio operation to take place from the Andaman & Nicobar Islands under the callsigns VU4NRO and VU4RBI. The permit covers the period 3-31 December 2004 and the authorization is for Bharathi Prasad, VU2RBI (team leader) and other four operators - D. N. Prasad,VU2DBP; Varun Sastry,VU3DVS; Ram Mohan, VU2MYH and Sarath Babu,VU3RSB. The QTH will be Port Blair, South Andaman Island (AS-001), and plans are to have two stations active; so far, no linears are available. Band and modes will be decided on-site based on the usual limits (antennas, hotel permits, electricity,

propagation, other gear, etc.). In addition, there will be no foreign pilot station for this operation.

"This effort will not be a mass arrival of crack operators with tons of gear" says Charles Harpole, K4VUD/VU3CHE. Charles adds, "this is a pilot project and in a year, if we all behave and have patience, Andaman could be much more open to ham radio visits or an on-going presence'." Bharathi is working on this project with the NIAR, the National Institute of Amateur Radio (www.niar.org), which is India equivalent to the ARRL. Stay tuned to your favorite DX bulletin or the ARRL web site for up to the minute information.

Brad Farrell, K4RT filed a petition in the U.S. District Court for the District of Columbia requesting review of the U.S. Fish and Wildlife Service's denial of use permits for Amateur Radio for Desecheo (KP5) and Navassa (KP1) islands, and the agency's ban of Amateur Radio from these islands, generally. The proceeding may take many months to move forward. Thus, a legislative solution would be most welcome, as it would save time and money.

The core of the legal argument is that the FWS has unlawfully interpreted the National Wildlife Refuge System Improvement Act to close Desecheo and Navassa. The statute does not limit refuge use to wildlifedependent recreational activities as the agency claims. The language of the statute identifies such activities as priority uses, but not exclusive uses. Furthermore, the evidence upon which the agency relied in closing the islands is speculative at best, which does not satisfy the evidentiary standards established by the federal courts for agency decision-making. The FWS's own records demonstrate that the agency has lied to Amateur Radio operators and Congressman about the purported safety issues on Desecheo and Navassa. In fact, the FWS has not, to date, denied this.

Mike Thomas, NA5U put the grass roots effort together, and at least 30 other DXers and a number of DX groups are assisting to move the legislative effort forward. We couldn't have gotten to where we are now without him.

Once you know your Congressmen's name you can go to http://clerk.house.gov/members/index.html for his snail mail address.

This bill is good for the lame duck session only. So we need to try to get it passed now. If it doesn't pass in the lame duck, it will be reintroduced in January. Staffers on Capitol Hill say that the more we can bring HR 5361 to the attention of Congressmen now, the better it may fare in January, and there is always the

chance it will pass during the lame duck if there is enough support. Please do not put off sending a letter to your Congressman. Even if you don't need KP1 or KP5, think about those outside the US who do and can not support this effort. It will only cost 37 cents for the stamp.

Mike, N9NS/VP2MNS will be returning to Montserrat the first two weeks of December. Joining him on this trip will be Pete, NØFW/VP2MW, Charlie; W6KK/VP2MKK, and probably John, N7CQQ/VP2MQQ. All are veteran DXpeditioners. They will arrive on Montserrat via Antigua on December 2, 2004 and leave on December 13. The guys will be in the ARRL 160-Meter CW Contest on December 3-4-5 and the ARRL 10-Meter Contest on December 11-12 using Pete's call, VP2MW. Outside of the contests they will be on all bands from 6 to 160 meters (including 60 meters) with some emphasis on the low bands and working Japan/VK/ZL. Info will be posted on their Web site at http://www.wb8xx.com/vp2m. Plans are to have on-line logs updated daily. QSL all calls via W8QID. Hopefully the volcano will remain quiet on this trip!

Look for Rudolf; DJ3WE, Falk; DK7YY, Ben;DL6RAI and Roberto; IV3IYH should be active now from Nepal as 9N7BCC until December 5th. There is a possibility that some of the operators may received their own private license/callsign. Team members plan to have three stations on the air simultaneously. Check the usual DX frequencies on 160-15m and also possibly on 10 meters. However, their emphasis will be on the lower and WARC bands. Also, look for RTTY operations. QSLs for 9N7BCC are via DK7YY. A German operator DL4VCR, Ruben Becker, DL4VCR, is now stationed at Camp Warehouse in Kabul, Afghanistan. He has been QRV as YA4Y on 30 and 40 meters CW. QSL via DL4VCR either via the bureau or direct to Ruben Becker, Glockenstr 41a, 66787 Wadgassen, GERMANY.

Members of the Canary Islands DX Society plan to activate special call EF8TDX from Tufia Rock, in the Canary Islands on December 11 and 12. Most, if not all, of the operators are EC8 stations and can not transmit above 21.200. Activity will be on 15 meters SSB only. They plan to post more information, after the operation, on their Web site at http://www.cidxs.com/. QSL via EC8AUA.

On December 18th and 19th look for special event station PC1ØØH (Papa Charlie One Hundred Hotel) to be QRV as they celebrate the 100th anniversary of the founding of the Dutch Coastal Station PCH Scheveningen Radio. Suggested frequencies are as follows: 1830, 1850, 3530, 3650, 7030, 7050, 10130, 10145, 14030, 14250, 18090, 18150, 21030, 21250, 28030, 28250, 144250 and 144250. Charlie WØYG and Burt, WØMY recently arrived rived on Christmas Island for a two-week plus stay as VK9XG. Their major aim on this operation is 160 and 80 meter DX QSOs. According to Steve, VK6VZ, the "VK9XG is likely to be the last lowband DXpedition on Christmas Island for some time, as accommodation on the island that is suitable for radio purposes is increasingly difficult to find." Look for the operation to be on 1828.5, listening 5 kHz up and down. Charlie and Burt will operate from sunset until sunrise every day, while dozing in the dead periods. VK9X is a much easier shot on 160m for Europe than North America, so few USA stations have worked VK9X on 160m. A maximum effort will go into working North America on both SP and LP. Please QSL direct to W0YG. Instead of sending through the Bureau, please use the "Logbook of The World" (LoTW).
