We wish to thank both authors of these two articles and hope that all of your questions will be fully answered by the time we have completed the debate and are ready to vote.

#### The Case for a Club Communications Trailer

Balancing the need for a communications trailer and the cost to procure, build and house it is not an easy decision, especially for a club that is losing members and struggling to keep accounts in the black. You may remember that a Vehicle Definition Task Force was selected to investigate the possibilities, and they concluded a Communications Trailer was needed to fulfill the club's mission statement, and was within our financial reach. "While its true that WCRA, or any organization could perform public service or emergency communications events without a vehicle, having one enhances the club's capabilities," says Joe, N9WRO.

Basis Services of a Communications Trailer:

1. To provide a location as a command post for public service events such as the Wheaton 4th of July Parade, Walk-a-thon, Special Olympics, Glendale Heights Labor Day Parade, Club Hamfest and Field Day. A trailer not only contains radios and an antenna, but stores other equipment, ready for efficient setting up at the event. Some members would appreciate getting club equipment out of their homes. Since the county has offered to store the trailer without charge, this helps us keep everything

The custodian brought out a couple of boxes of equipment from storage and we were done. I've operated Field Day as a station captain for years. Whether or not we have a vehicle makes no difference to me. I come with my equipment. In talking to other Field Day regulars, I don't see an overwhelming outcry

in one place.

2. Visibility and promotion. Education is a vital part of any good growth strategy. The Communications Trailer will be deployed at Scouting events, school demonstrations and civic events. We calculate that we have enough people in the club to deploy a trailer, and staff it. "For the public, the Communications Trailer could become the focal point of the club as the truck was in the past," says Mark, W9UZ. "The trailer is a form of advertising."

3. Although not our primary goal, if we should we need to rapidly deploy personnel and equipment in the case of a catastrophic event such as a tornado or terrorism attack, a Communications Trailer would be vital. Since many of our members are trained weather spotters, a command center in the trailer would be an appreciated help in a weather event. "Having all this equipment and know-how and no way to get it to an event," says Jim Ward, W9DHX, is like stepping up to the plate without a bat. We that we can't do Field Day without a vehicle.

The Boy Scout event is happening again in May. Peter, N9HDW, needs your help. His constraint is people to help, not a club vehicle. Don't use that event as an argument for why we need a trailer.

Public service – again, the constraint is often people, not a vehicle. While the trailer would be a benefit for some of these events, we need to look hard at how many times a year it would be used. Also, the current proposal is for a large trailer that could only be towed by a limited number of large pickups or SUVs. So the constraint becomes finding someone who can tow the vehicle. Renting a tow vehicle was mentioned, but does it make sense to spend the club's money to rent a vehicle to tow all of our stuff around to an event, when the same purpose could be served by loading several plastic crates into a car or van?

Emergency service – the task force keeps referring back to the Plainfield tornado, but the world has

need some way to quickly transport and set up a command center."

Why now is a good time to purchase a Communications Trailer?

Although the total cost the trailer suggested by the task force is \$10,000, we have a matching fund and member pledges totaling more than \$7,000. That means about \$3,000 is needed from club funds, but the \$3,000.00 is offset by \$1,000.00 from the sale of the truck, and also includes the cost of a generator which we should have with or without a vehicle. That brings the club contribution to less than \$1,000. "There will never be a better time for such a project. The new trailer that the committee has proposed," says Dale, NJ9E, "will eliminate the high cost of operating and maintaining our past motorized vehicle. Since over 70% of the cost to purchase the trailer is already pledged to this project by fellow members of the WCRA. I believe this demonstrates a sincere commitment by those members to make this project successful"

What is our relationship to the county Office of Emergency Management?

The OEM has no control over the Communications Trailer. We have no obligations to them. But they are aware how much value there is in shared goals. So much so that they have offered to provide a secure, easily accessible place to store the trailer. Five of our members are also paid-on-call members of the OEM and five more are reserve volunteer members who know the procedures for working with first responders. Through them, and the full-time OEM staff, the trailer will be available whenever we need it, 24/7.

The decision is yours. At the May meeting a vote will be taken on whether or not to make this purchase. A discussion will take place to answer any questions you still have. Just make the right choice. changed since 1990. A couple months ago we saw a presentation on how OEM has millions of dollars worth of trailers and equipment at their disposal to set up emergency communications. That didn't exist in 1990. We have no emergency plan or organization has a club. Is buying a trailer is going to change that? Their answer was we were going to have some letter of understanding with the OEM which would allow storage, access and automatically certify club members to use the equipment at an emergency situation. I'd like a lot more detail on that. Are we linking the club to OEM? Is that what the entire membership wants?

The video and presentation talked about how this trailer would build member recruitment.. For several years I was one to the club truck drivers. I drove it to multiple public service events. I was around it a lot at these events. I never had one person approach me and ask a question about the club or the truck. Yes, it's great to get our name out, but a banner will achieve the same thing as a trailer. We need member recruitment, but a trailer isn't going to solve that problem.

They presented a \$10,000 budget for the trailer. Several times during the presentation the need for an air conditioning unit was mentioned. That's an additional \$2,000 that isn't on their budget. Their contingency budget is \$250. How much money is the club really going to have to put into this over the long haul?

Despite the fact we're a radio club, the subject of radio equipment never came up. The equipment that was on the truck is now sitting in storage. Most of it hasn't been turned on in years. Much of it is very nice equipment – three all mode radios for two meters, 220 and 440 – and an Icom 735 HF radio.

It's also all old equipment, dating from the early 90s. If I was deployed to an emergency, I'd want to have equipment I could trust, not radios that have been in storage for years. So when does the club have to buy equipment to man this vehicle? I find it odd, that as a radio club, all the emphasis on this has been on a vehicle, and none on radios and antennas.

The club membership is declining. It's not declining because we don't have a vehicle, and buying a vehicle won't reverse that trend. What makes a club are radio-based activities and repeaters. I joined this club in '98 because I heard people on the repeater talking about Field Day. I went and visited Field Day and was impressed by the operation – not by the truck, but by the people and enthusiasm. Because of the hamfest we have more resources than most clubs. Are there other places those resources could go?

I have a lot of respect for the people on the other side of this argument, and I respect the fact they are willing to put their own money into the project. I just don't think we've seen a full accounting of what this project would eventually cost the club. I also have yet to hear a compelling argument as to why we need the vehicle.
